Dear Supporter,

At the Board's annual retreat last summer, we celebrated the Foundation's most successful year in our 30-year history. The concerted efforts of all the trustees combined to capitalize on the Foundation's growing momentum and strength to fulfill its mission. Initiatives developed and implemented within each of the Board's committees creatively achieved their goals:

- Broadened the awareness of the work of the Foundation within the St. Anne Community.
- Incorporated best practices for the internal efficiencies of the Foundation.
- Initiated new activities and events to increase fundraising success, including the inaugural Monte Carlo Night to kick-off the Annual Giving Campaign.
- Helped fund the operating budget needs of St. Anne Catholic School through a \$250,000 Annual Grant.
- Funded critical enhancements for St. Anne Catholic School, specifically two special grants totaling \$244,022 to complete the Ideal Classroom project.
- Met the growing needs for financial assistance at St. Anne Catholic School by supporting needs-based financial assistance, providing student scholarships, and increasing the fundraising support to the Father John Robbins Bourse.

For the 2011–2012 school year, the Foundation provided St. Anne Catholic School with funds exceeding \$527,000. Combining the Foundation's contributions to the school over the last two years, the total is significantly more than one million dollars. Since 1982, together with our supporters, the Foundation has been and will continue to be the largest fundraising source and contributor to St. Anne Catholic School.

The Foundation is proud to be a strategic member of the St. Anne Community. We seek to build meaningful relationships for the benefit of our sole grantee—St. Anne Catholic School. We earnestly accept our leadership role of support for the children and families of St. Anne Catholic School. We value our partnerships with other leaders throughout the St. Anne Community and beyond. Above all, we are very grateful for the generosity of our supporters.

At the annual retreat I concluded two very fulfilling years as Foundation President, and am currently serving my last year on the Board. 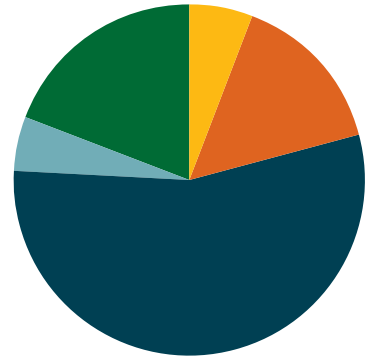

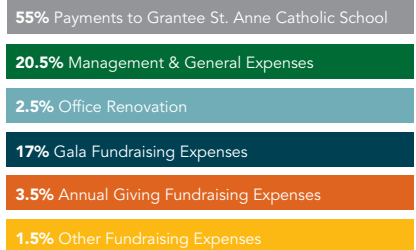
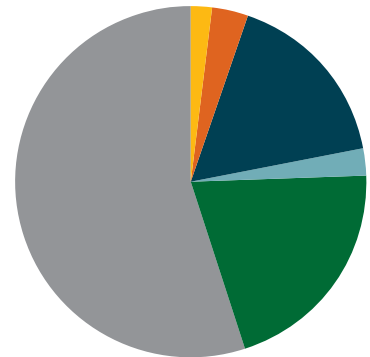

Building a Strong Foundation

30 years ago, seven visionary leaders in the St. Anne Community formed a non-profit foundation to raise funds for St. Anne Catholic School. The year was 1982 and the school was just over 50 years old. Based on a desire to ensure the perpetuation of quality Catholic education in the St. Anne Community, the leaders collaborated to create the St. Anne School Foundation.

Today, the Foundation continues the work and vision of our founders—raising, growing and administering funds to support the students and families of St. Anne Catholic School—funds that have exceeded one million dollars over the last two years.

For 2011–2012, this support included a \$250,000 annual grant, a \$225,000 matching grant and a \$19,022 special matching grant for the Ideal Classroom, as well as more than \$33,000 in student and faculty scholarships.

The St. Anne School Foundation is pleased to serve as a foundation solely focused on St. Anne Catholic School—a co-ed, preK-3 through 8th grade school serving nearly 500 students from more than 50 zip codes throughout the Houston area. The school’s mission—to develop students academically, spiritually, culturally and physically in a Catholic environment—forms the pillars and strength of the support provided by the St. Anne School Foundation.

The classroom is the hub of the learning environment at St. Anne Catholic School. Thanks to the completion of the Ideal Classroom project, the St. Anne campus abounds with classrooms filled with forward-looking resources like Smart Boards and I-pads. These classroom enhancements engage students and support the work of the school's knowledgeable and caring teachers. Inside these classrooms, academic excellence is fostered, quality education is nurtured, and life-long learning is cultivated.

Thanks to the generosity of our donors, the St. Anne School Foundation is pleased to have provided special matching grants to help the school complete the Ideal Classroom project in time for the start of the 2011–2012 school year—six years ahead of schedule.

Students and teachers alike derive strength and determination from their faith. The Foundation trustees are committed to ensuring that St. Anne Catholic School remains affordable for students seeking a quality Catholic education.

The Foundation accomplishes this goal in two ways: (1) the school designates a major portion of the Foundation's annual grant for needs-based tuition assistance; and (2) the Foundation provides both needs-based and merit-based annual scholarships for students.

Faculty continuing education also is supported in two ways: the Foundation's annual grant and scholarships that are specifically designated for learning opportunities and/or classroom resources for teachers.

Upon his death, Father John Robbins asked the Foundation to create a scholarship fund to maintain the enriching diversity of St. Anne Catholic School—where the uniqueness of each child is embraced and the diversity of the student body is celebrated.

The Fr. John Robbins Bourse Scholarship was developed in December 2009 and today includes funds in excess of \$450,000. With the kind generosity of supporters, four students attended St. Anne Catholic School with Bourse Scholarships during the 2011–2012 school year, and 11 students in 2012–2013.
